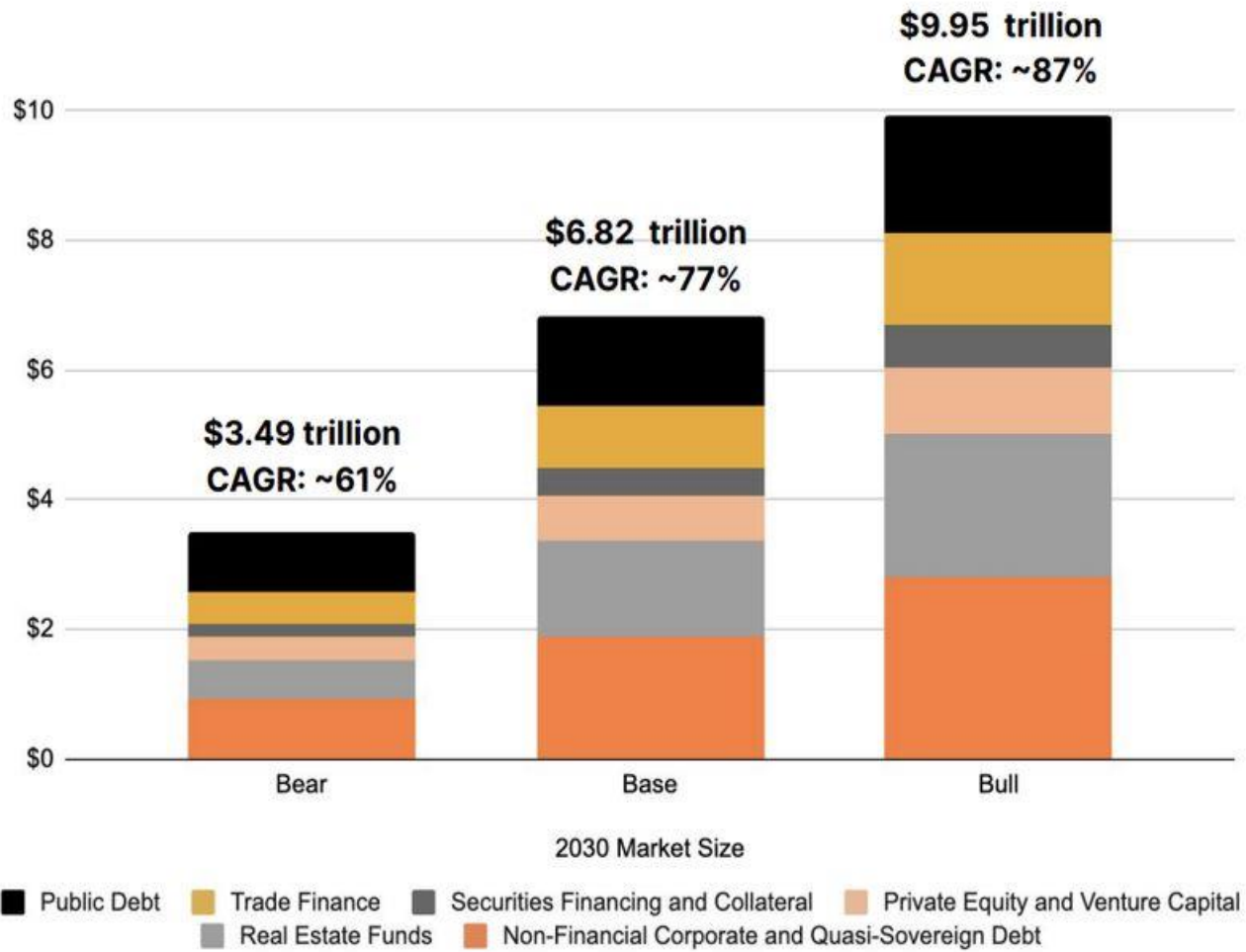

What Operations Does GTP Perform?

Tokenization: The first step is to tokenize the asset. This involves creating digital tokens on a blockchain that represent ownership or a share in the asset's value. The number of tokens issued is often proportional to the value of the underlying asset. 1 Dolar=1 Token

Smart Contracts: Smart contracts are utilized to automate various aspects of the offering. They define the rules for ownership, transfer, and distribution of dividends to token holders. These smart contracts can also incorporate conditions and terms specific to the offering, such as lock-up periods or discounts for large investors.

Legal and Regulatory Compliance: It's crucial to ensure that the offering complies with relevant legal and regulatory requirements, particularly if the tokens are considered securities. In many jurisdictions, securities regulations apply to token sales, and compliance is necessary to avoid legal issues.

Exchange Listing: After the token sale, you can list the tokens on cryptocurrency exchanges that support trading of asset-backed tokens. This enhances liquidity and provides an opportunity for investors to trade their tokens.

Asset Custody: Safeguard the underlying asset that backs the tokens. Investors need assurance that the asset is being properly managed and maintained.

Reporting and Transparency: Maintain transparency in reporting and provide regular updates to token holders regarding the performance of the underlying asset, dividend distributions, and other relevant information.
